## ΠΟΡΙΣΜΑΤΑ ΚΑΤΑΓΕΛΙΩΝ (ΑΝΑΔΕΔΒΜ)



The objective was achieved through three components: by strengthening the administrative capacities of IPA structures and institutions responsible for combating fraud, corruption, and other forms of illegal activities in the system (AFCOS network), by conducting training/seminars for their officials, and by evaluating the Strategy for Combating Fraud and Irregularities Management for the protection of the financial interests of the European Union for the period 2019-2022.

The AFCOS office, together with its partners in this TwL project, sought to improve the development of the administrative capacities of the entire AFCOS system, i.e., to enhance the financial management and control system.

The opening remarks at the ceremony marking the successful completion of the project were given by **Agata Stasiak**—Head of the Contracts, Finance and Audit Department at the Delegation of the European Union to Montenegro, **Miloš Medenica**—State Secretary at the Ministry of Finance, and **Panagiotis Partsos**—the Ambassador of the Republic of Greece to Montenegro.

Afterwards, project leaders **Nataša Kovačević** from Montenegro and **Konstantinos Pavlikianis**, who was the representative of Greece, presented all the activities, results, and achievements of the project.



Irregularities and Fraud at AFCOS office, who lauded the active cooperation between Montenegrin and Greek experts, emphasising the significant contribution to the project's success. She believes the project will pave the way for improved administrative capacity in Montenegro, efficient utilisation of Anti-Fraud Funds, and robust management and control of irregularities and fraud. This will have a profound impact on the implementation of Chapter 32 - Financial Control and the broader process of Montenegro's accession to the EU. The Greek Project Leader, Mr. Konstantinos Pavlikianis, shared key conclusions from the project's activities.
